## GENERAL INFORMATION

<b>AWARDS:</b>	Divisions will be pinned separately. Ribbons first place through sixth place for each class.
<b>CHAMPIONSHIPS:</b>	High Point, High Point Reserve, and High Percentage for each level in each division.
<b>STABLING:</b>	Limited 12x12 permanent stall. \$75 for weekend (stalls available 3 pm Friday through 3 pm Sunday) or \$40.00 per day/one overnight. (Stalls available 3pm Friday to 5pm Saturday or 6pm Saturday to 3pm Sunday. Stalls available on a first come first serve basis, no reservations without payment. No tack stalls available. Light bedding provided, additional bedding available at \$7 per bag. Stabling is reserved with entries at <a href="http://WWW.HORSESHOWOFFICE.COM">WWW.HORSESHOWOFFICE.COM</a> . <u>No phone reservations accepted.</u> Upon check-in, a \$10 deposit will be collected for each stall. The \$10 deposit will be returned at the end of the day if the stall is left clean.
<b>HAUL-IN FEE:</b>	\$20 per non-stabled horse. No non-competing horses.
<b>CAMPING:</b>	\$15 per night. No hookups; may bring generators.
<b>FOOTING:</b>	Groomed sand competition arena and grass warm-up.

<b>OFFICE FEE:</b>	\$25 per horse/rider combination. Fee applied for each show.
<b>POST ENTRIES:</b>	At discretion of show management with 50% additional fee.
<b>REFUNDS:</b>	Full refund, less \$25 office fee, up to closing date. No refunds after closing date.
