TEST OF CHOICE: All Test of Choice Classes are to be scored together if smaller than 6 riders

DRESSAGE TESTS: The 2019 USEF dressage tests and 2017 WDAA dressage tests. All tests may be read. Horses can be shown in only two consecutive levels. (Example – Intro and Training Level or Training and First Level, etc.)

AWARDS: Each division will be pinned separately (First-Sixth Place Ribbons).

CHAMPIONSHIPS: High Percentage and Reserve High Percentage for each Level/Division.

OFFICE FEE: \$30 Per Show.

Entry Divisions:

Open = Professional who takes any compensation for training

Adult Amateur = A person over the age of 21 who does not provide training services

Young Rider = 15-21 years of age

Junior= 15 and under.

FREESTYLES: Please provide music to horse show office. Sound check will be conducted at a break

STABLING: Limited permanent Stalls. \$35 per day. Light starter bedding provided, bring your own additional bedding. Bring your own water buckets. Stalls available 6:30am the day of the show. No overnight stabling available.

FOOTING: One outdoor and one indoor sand arena.

ENTRIES: ALL entries submitted by mail (NO ENTRIES will be excepted via TEXT OR MESSENGER). Entry Fee is **\$25** per class. Make checks payable to ***BRR Enterprises, LLC***

Entries to: ***BRF Show Secretary*** 490 Rissman Lane, Ortonville, MI 48462. ***Entries must be post marked on or before the above listed closing dates for each show. Entries are taken on a first come/first served basis until the show is full or the closing date, which ever comes first. Entries postmarked after the closing date will be assessed a \$10 post entry fee per class if accepted. No entries accepted without a negative Coggins that is dated within 12 months of date of BRF show, all signatures and full payment.***

GATE: There is a security gate at the front of the property. Please Make wide turns with horse trailers!

Helmets: Required to be on and buckled at all times while mounted according to USEF.

(Fun Classes) Groom, Parent, Lead line Classes: These are fun classes that emphasize SAFETY 1st! All riders must wear helmets and have signed waivers before mounting, and be under control at all times. These will be the LAST CLASSES BEFORE LUNCH.

POST ENTRIES: At discretion of show management with 50% additional fee.

REFUNDS: Full refund up to closing date, minus office fee. NO refunds after closing date.

TIMES: Ride times will be posted on ADA website, Lone Tree Stables Facebook and brilliantreflectiondfarm.com ([www.alldressageassociation.com](http://www.alldressageassociation.com)).
